1. I understand that as a Bella Vida Concierge Concierge. ("BVC") Independent Agent ("IA"):
 - a. I have the right to offer for sale products and services offered through BVC in accordance with these Terms and Conditions.
2. I agree to present the BVC Marketing and Compensation Plan and BVC products and services as set forth in official BVC literature.
3. I agree that as a BVC IA I am an independent contractor, and not an employee, partner, legal agent, or franchisee of BVC . I agree that I will be solely responsible for paying all expenses incurred by myself, including but not limited to travel, food, lodging, secretarial, office, long distance telephone and other expenses. I UNDERSTAND THAT I SHALL NOT BE TREATED AS AN EMPLOYEE OF BVC FOR FEDERAL OR STATE TAX PURPOSES. BVC is not responsible for withholding, and shall not withhold or deduct from my bonuses and commissions, if any, FICA, or taxes of any kind.
4. I have carefully read and agree to comply with the BVC Policies and Procedures and the BVC Marketing and Compensation Plan, both of which are incorporated into these Terms and Conditions. I understand that I must be in good standing, and not in violation of the Agreement, to be eligible for bonuses or commissions from BVC. I understand that these Terms and Conditions.
5. IA authorizes BVC to use his/her name, photograph, personal story and/or likeness in advertising or promotional materials and waives all claims for remuneration for such use.
6. A faxed copy of the Agreement shall be treated as an original in all respects.
7. IA affirms that he/she is of legal age in the state of execution of this Agreement.
8. All comments, feedback, suggestions and ideas that you disclose, submit or offer to BVC are the exclusive property of BVC.
9. PROPRIETY NATURE OF REPORTS- IA agrees that such information is proprietary and confidential to both BVC and the individual IA and is transmitted to IA in confidence. IA agrees that he/she will not disclose such information to any third party directly or indirectly, nor use the information to compete with BVC directly or indirectly. IA and BVC agree that, but for this agreement of confidentiality and nondisclosure, BVC would not provide the above confidential information to the IA.
10. TERMINATION-The IA Agreement may be terminated by BVC at any time if just cause is founded. The right of a terminated Independent Agent to receive compensation from BVC ceases immediately from the date of the termination. Furthermore, a terminated IA must stop selling packages, using BVC promotional materials, trademarks, trade names, service marks, logos and color schemes representing himself/herself as a BVC IA or act in any way which may be adverse to the business of BVC or any other IA. Upon termination of the IA Agreement, all [sales activity reports] in the possession of the IA shall be returned to BVC.
